## **REGISTRATION & RELEASE**

With any physical activity there is always the potential risk of injury and "PEAC" shall extend all efforts to maintain a safe environment as it may relate to Participant's involvement in any play areas, facilities, equipment and/or as a participant in any program or event offered by PEAC at 1440 Lower Ferry Road, Ewing, NJ.

On behalf of "Participant" as identified in the KidsKamp Registration Form under the age of 18, I as Parent or Legal Guardian acknowledges, appreciates, understands, and agrees to the following: **1:** I represent that I am the Parent or Legal Guardian of the Participant as named in this registration form. **2:** I acknowledge and understand that there are risks of injury associated with participation in any PEAC program(s) and/or activities, the use of the play area(s) and equipment including, but not limited to: contusions, fractures, scrapes, cuts, bumps, paralysis or death. **3:** I, for myself as Parent or Legal Guardian and any others associated with Participant(s) involvement either as an observer or by participation in any activity, program and/or event within or about the facilities, and the Participant(s) named, willingly assume the risks associated with participation and accept that there are also risks that may arise due to interactions with OTHER PARTICIPANTS. **4:** I agree that the Participant named, and I shall comply with all stated and customary Terms & Conditions, posted safety signs, Rules & Regulations, Code of Conduct and verbal instructions as conditions for participation in any program, activity and/or event at PEAC. **5:** I, for myself, the Participant named, our heirs, assigns, representatives, and next of kin agree to hold harmless and indemnify the PEAC, their affiliates, officers, employees and representatives from any and all injuries, claims, liabilities or damages from participation. **6:** I additionally agree to indemnify and reimburse PEAC, their subsidiaries and affiliates, officers, employees and representatives for any expenses associated with PEAC's defense of any and all claims, injuries, liabilities or damages arising from participation. **7:** I understand that PEAC reserves the right, at their sole discretion, to accept, refuse and/or terminate any registration and/or participation by and for any Participant, including, but not limited to any guest, spectator and/or customer associated (or not associated) with any Participant and I as Parent or Legal Guardian, will immediately comply and cooperate with any decision, determination and/or action that is presented or stated to me or Participant by PEAC in regard to Participant(s) regardless if presented in writing or verbally. **8:** I represent that Participant is physically able and mentally capable to participate, has no medical condition that will restrict or limit participation or present a concern, and that it is Participant, Parent and/or Legal Guardian's liability and/or responsibility to inform PEAC of any known physical, medical, health and/or mental conditions that may restrict and/or prohibit Participants ability to participate in any PEAC programs and/or activities, to which PEAC reserve the right for the benefit of the Participant, to refuse and/or decline participation. **9:** I represent that I am legally competent to understand and willing to comply with the terms and conditions of this agreement, which PEAC reserves the right to change, modify and/or update without notice, and to complete the registration on behalf of Participant. **10:** I represent my understanding and compliance on behalf of the Participant, that this agreement, subject to PEAC's acceptance and/or termination, shall remain valid, enforceable and in full effect for the initial registered term and shall continue to be observed and enforced in the event of any future claims.

## **TERMS & CONDITIONS**

**EMERGENCY RELEASE & MEDICAL CONDITIONS** – although every precaution shall be taken, personal injuries may occasionally occur. In case of a medical emergency, PEAC will proceed to make every reasonable effort to contact Parent(s). In the event a contact is unavailable, I as Parent or Legal Guardian hereby authorize and I grant permission to PEAC to proceed with medical attention as PEAC feels may be necessary for the welfare of the Participant. Parent or Legal Guardian is responsible to inform PEAC of any known Physical Disabilities, Medical Conditions and/or Allergies at the time of registration.

**MEDICAL & PHYSICAL CONDITION REPRESENTATION** - I understand that PEAC is not authorized to administer any type of medication and that if my Participant requires medication during camp hours, then I as Parent or Legal Guardian must personally administer my Participant's medication. I declare and acknowledge that my Participant is physically, medically and/or psychologically capable to participate in the KidsKamp Programs and Activities. I also understand that PEAC recommends and if I have a concern for my Participant that I should consult a physician. I have disclosed and revealed to PEAC Participant's medical history, any physical limitations or concerns, any health problems and/or any medical needs that may exist.

**PAYMENTS, SERVICE CHARGES & UNPAID BALANCES** – Full payment is due and to be paid prior to Participants commencement or involvement in any program or activity. In the event a Participant's payment is returned for any reason, PEAC has the right to charge an additional fee of \$25 for each incident. Should any balance(s) or payment(s) due not be resolved within 30 days, PEAC has the right to assess a monthly service fee of 2% (24% annually) until any outstanding balances are paid. In addition, should PEAC seek assistance to collect payment, Custodian and/or Participant shall be responsible for all cost associated with any collection.

**REFUNDS** – Full payment is due and payable prior to Participants involvement in any program or activity. No refunds or credits will be issued for any missed sessions.

**NON-TRANSFERABLE** – Purchased sessions are to be used by register participant ONLY and are non-transferable.

**LOSS OF PERSONAL ITEMS** – PEAC, its employees, agents, and representatives are not liable or responsible for the loss of Participant's personal property.

**DAMAGE TO THE FACILITY** - In the event intentional damaged is inflicted to the facility and/or equipment by a registered Participant or Observer, other than normal wear and tear, Parent, Legal Guardian and/or Participant shall be responsible and liable for the repair or replacement.

## **RULES & REGULATIONS**

**SESSIONS, DAYS & HOURS** – Participants can only participate in their selected sessions, days and times. No refunds or credits will be made for missed days/sessions or refund or return of deposits in the event Participants does participate in their agreed upon week or sessions.

**DROP OFF & PICK UP** – Children are to arrive no sooner than 10 minutes prior to the scheduled starting hours and Parents are to sign-in participants at the designated location. Participants are to be picked up at the scheduled conclusion time and Parents must sign the participant out. I, as Parent or Legal Guardian agree to pay a late pick-up fee of \$5.00 per child if participant is picked up more than 10 minutes past the concluding time. An additional \$5.00 will be charged for each additional 10-minute period thereafter.

**MARKETING RELEASE** - I DO \_\_\_\_\_ DO NOT \_\_\_\_\_ (initial) authorize and grant PEAC the exclusive right to include my Participant in photography that shall be utilized to promote and advertise PEAC and/or its affiliate companies, which may appear in their website, printed material, brochures, flyers, newspaper articles or advertisements. All material shall become the exclusive ownership of PEAC for the sole purpose of marketing and promotion and shall not be shared or distributed for any other purpose without the authorization or consent of the Parent or Legal Guardian. I/we waive all rights to ownership and any expectation for royalties.

**DRESS CODE** – Participants are to dress appropriately for prevailing weather conditions, safety and for physical fitness activities (proper footwear required). Each Participant shall be issued one KidsKamp tee shirt for the season regardless of the number of sessions.

**FOOD & DRINKS** – Beverages and snacks will be served. Participants can bring bottled water or personal water bottles containing water only. Full day Participants will be required to bring a lunch. Be sure to list and alert PEAC of any food allergies.

**CONDUCT & BEHAVIOR** – At the sole discretion of PEAC, should a Participant not behave appropriately or his/her conduct be unacceptable or PEAC determines the Participant cannot adjust to the Program or becomes a distraction or detrimental to the Program, then PEAC reserves the right to remove the Participant from the Program and a refund equal to 50% of the remaining term will be issued. This right shall also apply towards the conduct or behavior of a Parent who may express a high level of dissatisfaction with the Program.

**WELL CHILDREN** – For safety and the well being of other Participants, PEAC has the right at its sole discretion to make the determination regarding a Participant's health based on our experience and general accepted health practices to refuse or remove a Participant due to sickness or illness.

**VIOLATIONS OF RULES & REGULATIONS:** The Rules & Regulations and other terms, conditions, policies and procedures have been developed to maintain a safe and organized operation. Failure by a Parent, Legal Guardian and/or Participant to observe and comply may, at PEAC's sole discretion, result immediate termination and removable with no obligation to provide a credit or refund.
